Superior Court Judge Thierry Patrick Colaw (Ret.) declares under penalty of perjury pursuant to 28 U.S.C. § 1746 as follows:

1. Plaintiffs' Counsel in *Yahoo! Inc. Private Information Disclosure Cases*, Judicial Council Coordinated Proceeding No. 4895 (the "JCCP") have retained me to perform a review and evaluation of the timesheets and expense reports which JCCP Plaintiffs' Counsel are prepared to submit to the Court, and have asked me to identify potential issues or concerns with respect to the attorneys' fees and costs they seek.

2. I have agreed to undertake this assignment with the understanding that my scope is narrowly limited to the matters above (which I believe are squarely within my experience, training and ability as a former Superior Court trial judge), and I take no position concerning the merits of the underlying case, the claims or defenses asserted by either party, the fairness or reasonableness of the settlement, the fees and costs sought by attorneys in the MDL, and any other matters not within the

1 above-described scope.

2 3. As a result of measures described below, JCCP Counsel total lodestar has been  
3 reduced by approximately 23% from their original submission in 2018.

4 Background

5 4. I am familiar with the events in the case based on my time as the presiding  
6 coordination trial judge of the JCCP. I reviewed the following materials in order to refresh my  
7 recollection of the events I presided over and become familiar with events that occurred after I stepped  
8 down from the bench:

- 9 a. The Civil Case Summary pertaining to the JCCP, which summarizes every event and  
10 filing in the case, attached hereto as Exhibit 1;  
11 b. All of the timesheets and expense reports submitted by JCCP Plaintiffs' Counsel;  
12 c. A chronology of the case provided by JCCP Plaintiffs' Counsel;  
13 d. The Declaration of Daniel S. Robinson in Support of Plaintiffs' Motion to Notice  
14 Class, ECF No. 369-16, submitted in this action;  
15 e. The JCCP and MDL billing and expense protocols; and  
16 f. Filings, pleadings, and other documents that I requested from JCCP Plaintiffs'  
17 Counsel during my review and analysis.

18 5. I have also reviewed the Report and Recommendations of Special Master Re: Award  
19 of Attorneys' Fees and Reimbursement of Litigation Expenses in *In re Anthem, Inc. Data Breach*  
20 *Litigation*, Case No. 15-md-02617-LHK, ECF No. 1008.

21 6. I am currently practicing as a mediator, arbitrator, and private neutral at Judicate West.  
22 It is my understanding that that JCCP Plaintiffs' Counsel will bear the expense for this review and  
23 analysis of the timesheets and expense reports and will not seek reimbursement of this cost from the  
24 Court.

25 7. Before becoming a neutral, I spent twenty-one years serving as a trial judge for the  
26 Superior Court of Orange County in Orange County, California, where I presided over thousands of  
27 civil cases. I served eleven years on the General Civil Panel and nine years on the Complex Civil

1 Panel, where I presided over a broad spectrum of challenging cases including class actions,  
2 construction defects, toxic torts, California Environmental Quality Act, and other multi-party  
3 complex matters. I also spent ten years serving as a member of the Executive Committee for the  
4 Orange County Superior Court.

5 8. I am a long-time active member of the American Board of Trial Advocates  
6 (“ABOTA”) and Association of Business Trial Lawyers and have received “Judge of the Year”  
7 awards from various organizations. I also served as the 2012 President of the Orange County Chapter  
8 of ABOTA.

9 9. Prior to serving on the bench, I was in private practice for 20 years representing both  
10 plaintiffs and defendants in civil litigation. As an attorney I was AV rated by the Martindale-Hubbell  
11 directory. I am an alumnus of the Santa Clara University School of Law, and the University of  
12 California, Los Angeles. I am also a United States Navy veteran and I served two tours of duty in  
13 Vietnam.

14 10. During my time on both civil panels, I presided over 100 class action cases.

15 11. In numerous class action cases I presided over which resulted in settlement, I evaluated  
16 requests for attorneys’ fees sought by class counsel for plaintiffs.

17 12. I performed an *in camera* review of bills and costs incurred by attorneys during the  
18 pendency of more than 300 cases, including class actions over which I presided.

19 13. In addition to my work as a trial judge, I have extensive training and experience from  
20 my twenty years in private practice on the ethical, proper, and efficient methodologies employed by  
21 lawyers for billing time in a variety of matters.

22 14. My experience as a trial judge, and in private practice, has given me valuable insight  
23 into how to review and evaluate time and expenses claimed by attorneys in complex litigation. I  
24 understand which costs are reasonable and customary in the ordinary course of complex, class action  
25 litigation, including document vendors, deposition vendors, experts, and other costs. I also have  
26 extensive experience reducing or striking time and expenses that are unreasonable, excessive,  
27 unnecessary, duplicative, or otherwise improper. In many instances as a trial judge, I issued orders

1 that substantially reduced or eliminated requests for attorneys' fees in class action cases.

2 *Yahoo! Inc. Private Information Disclosure Cases*, JCCP No. 4895

3 15. Below is a summary of events in the Yahoo JCCP litigation that occurred while I was  
4 a judge presiding over the matter.

5 16. On September 29, 2016, I was assigned *Ruiz v. Yahoo!, Inc.*, Case No. 30-2016-  
6 00878180 (Orange County Superior Court), one of the first cases filed in California state court  
7 involving the data breaches announced by Yahoo in 2016 (the "Data Breaches").

8 17. On November 2, 2016, the then Presiding Judge of the Superior Court of Orange  
9 County, the Hon. Charles Margines, assigned me as the coordination motion judge for the JCCP.

10 18. After I was appointed as coordination motion judge, the parties appeared and agreed  
11 on the issue of coordination but disagreed on where the coordinated proceedings should be heard,  
12 resulting in the parties filing a stipulation for a briefing schedule on November 15, 2016. On  
13 December 7, 2016, I issued a stay of all cases in the JCCP and set a hearing date for January 20, 2017,  
14 directing the parties to submit individual statements on the proper site for coordination by January 3,  
15 2017. After both parties filed their briefs and after hearing oral argument, I ordered the parties to  
16 submit additional briefing on the issue of coordination and I set a further hearing for February 10,  
17 2017. Ultimately, after reviewing the additional briefs and hearing additional argument on the issue,  
18 on February 15, 2017, I issued an order recommending that (1) the coordination petition be granted;  
19 (2) the Orange County Superior Court be designated as the site of the coordination proceedings; and  
20 (3) the California Court of Appeal, Fourth Appellate District, Division Three, be designated as the  
21 reviewing court.

22 19. On March 14, 2017, I was assigned as the coordination trial judge to preside over the  
23 JCCP.

24 20. On April 12, 2017, I set an initial Case Management Conference ("CMC") for May  
25 26, 2017, resulting in the parties submitting a joint statement and proposed Case Management Order  
26 ("CMO") No. 1 on May 11, 2017.

27 21. At the May 26, 2017 CMC, I approved CMO No. 1, appointing Daniel S. Robinson of

1 Robinson Calcagnie, Inc. and Brian D. Chase of Bisnar Chase LLP as Plaintiffs’ Co-Lead Counsel,  
2 and Eric A. Grover of Keller Grover LLP and Jeremiah Frei-Pearson of Finkelstein, Blankinship,  
3 Frei-Pearson & Garber, LLP as Plaintiffs’ Liaison Counsel. In addition to those attorneys, I also  
4 appointed Neil B. Fineman of Fineman Poliner LLP, Robert Samini of Samini Scheinberg PC, Nathan  
5 M. Smith of Brown Neri Smith & Khan LLP, and Brian S. Kabateck of Kabateck Brown Kellner LLP  
6 as members of the Plaintiffs’ Steering Committee.

7 22. On May 25, 2017, the day before the initial CMC, Yahoo moved to stay the JCCP.  
8 On June 12, 2017, JCCP Plaintiffs filed their opposition to the motion to stay, and on June 16, 2017,  
9 Yahoo filed its reply. On June 23, 2017, the parties argued their respective issues on the motion to  
10 stay. On June 28, 2017, I denied Yahoo’s the motion, finding that the “JCCP plaintiffs are all  
11 California residents who seek to litigate California state law claims against a California defendant in  
12 California state court. This court should and does give the choice of forum here great deference. [See  
13 *Benitez v. Williams* (2013) 219 Cal.App.4th 270, 277, and *Thompson v. Continental Ins. Co.* (1967)  
14 66 Cal.2nd 738, 7422.]” I also found that the “*Caiafa* factors [see *Caiafa Prof. Law Corp. v. State*  
15 *Farm Fire & Cas. Co.* (1993) 15 Cal.App.4th 800, 804] as described in the briefs and California’s  
16 interest in applying its own consumer protection statutes and regulating its own citizens, and basic  
17 principles of comity, efficiency and fairness weigh strongly in favor of denying this request that the  
18 court issue a stay of the JCCP.”

19 23. Prior to the decision on Yahoo’s motion to stay, JCCP Plaintiffs filed a consolidated  
20 complaint on June 27, 2017, asserting the following six causes of action on behalf of a class of  
21 California citizens:

- 22 i. violation of California’s Consumers Legal Remedies Act, Cal. Civ. Code §§ 1750, et  
23 seq.;
- 24 ii. violation of California’s Unfair Competition Law, Cal. Bus. & Prof. Code §§ 17200,  
25 et seq.;
- 26 iii. violation of California’s Customer Records Act, Cal. Civ. Code §§ 1798.80 et. seq.;
- 27 iv. common law claims for negligence;

- v. common law claims for breach of contract; and
- vi. invasion of privacy under the California Constitution.

24. On July 27, 2017, Yahoo demurred to the Complaint arguing JCCP Plaintiffs lack standing to pursue each of their claims and challenging each of the other causes of action on other grounds. On August 14, 2017, JCCP Plaintiffs filed their opposition, and on August 18, 2017, Yahoo filed its reply in support of its demurrer. The hearing on the demurrer was ultimately continued to December 8, 2017, where the parties argued their respective positions. On December 13, 2017, I entered an order overruling Yahoo's demurrer except for Plaintiff's CLRA claim.

25. Throughout this period, I understand that the parties were engaged in written discovery as well as negotiations regarding additional proposed orders, such as the Stipulated and Proposed Protective Order that were ultimately filed on July 21, 2017.

26. On or around December 20, 2017, I stepped down from the bench, and I retired on February 28, 2018. Based on my review of the record, I believe the last status conference I oversaw on the case was on or about January 2, 2018. The case was then reassigned to the Hon. Randall Sherman effective January 2, 2018. I understand that the JCCP was ultimately reassigned to the Hon. Glenda Sanders on or about April 3, 2018.

Events Post-Dating My Role as the Presiding Judge of the JCCP

27. After I was approached by the JCCP Plaintiffs to audit and critique the timesheets and expense reports in this matter, I familiarized myself with the events of the case following my service as the judge presiding over the JCCP. As discussed above, I have reviewed the Civil Case Summary sheet (Exhibit 1), a chronology of the case provided by JCCP Plaintiffs' Counsel, the Declaration of Daniel S. Robinson in Support of Plaintiffs' Motion to Notice Class (ECF No. 369-16), and additional filings and documents that I requested from JCCP Plaintiffs' Counsel.

28. Based on my review of the above-mentioned documents, JCCP Plaintiffs' Counsel appear to have done substantial work on this case both before and after my involvement, and appear to have been efficient and reasonable in their hours billed and costs incurred.

29. I provide the following summary of the substantial work done by Plaintiffs' Counsel

1 in the JCCP not discussed above, which is based upon my review of the above-mentioned documents,  
2 my requested review certain documents such as discovery propounded, and my discussions with  
3 JCCP Plaintiffs' Counsel.

4 Written Discovery

5 30. On May 26, 2017, JCCP Plaintiffs served Yahoo with their First Set of Requests for  
6 Productions of Documents consisting of 119 requests, which Yahoo responded to on July 25, 2017.

7 31. On July 21, 2017, the parties filed their Stipulated and Proposed Protective Order.

8 32. On October 3, 2017, the parties entered into a Stipulated Order Governing Discovery  
9 of Electronically Stored Information.

10 33. Between October 2017 and January 2018, the parties negotiated the search terms  
11 Yahoo would use in in both the JCCP and the MDL actions that determined what documents would  
12 be produced and for which custodians.

13 34. On October 5, 2017, Yahoo made its first document production. It is my  
14 understanding based on the representations of JCCP Plaintiffs' Counsel that Yahoo ultimately  
15 produced 40 batches of documents for approximately 60 custodians containing over 9 million pages.  
16 The billing records show that JCCP Plaintiffs' Counsel applied document review analytics to this  
17 massive production and conducted targeted review projects overseen by Co-Lead Counsel where  
18 relevant documents were identified in preparation for depositions and other discovery. JCCP  
19 Plaintiffs' Counsel also issued third-party subpoenas and received thousands of additional documents  
20 from several former Yahoo employees who were deposed by both the JCCP and MDL. To ensure the  
21 reasonableness of the billing for document review, JCCP Plaintiffs' Counsel adopted a billing  
22 protocol which, according to Plaintiffs' Counsel and on my review, appears to be consistent with the  
23 MDL's protocol. JCCP Plaintiffs' Counsel also instituted a document review protocol for reviewers  
24 which appears to have helped minimize duplication and increase efficiency. JCCP Plaintiffs' Counsel  
25 have imposed a reduction for all document review and contract attorney billing to \$240 per hour.

26 35. On December 13, 2017, Yahoo served the JCCP with its First Set of Special  
27 Interrogatories and First Set of Requests for Production of Documents, which JCCP Plaintiffs'



1 Counsel responded to on March 12, 2018. On February 5, 2018, JCCP Plaintiffs' Counsel served  
2 Yahoo with their First Set of Requests for Admissions, Special Interrogatories, and Form  
3 Interrogatories, which Yahoo responded to on May 8, 2018. The parties appear to have met and  
4 conferred over numerous discovery disputes that arose throughout the case.

5 36. JCCP Plaintiffs' Counsel also appeared to establish point-persons, namely Court-  
6 appointed liaisons Eric Grover and Jeremiah Frei-Pearson, for addressing responses to Class  
7 Representative discovery and coordinating/communicating with MDL counsel concerning discovery  
8 and scheduling. The former, Mr. Grover, worked extensively with Class Representatives,  
9 communicating about discovery and the status of the litigation, helping them run Defendants' search  
10 terms on their email accounts, and, in some instances, helping them prepare images of their hard  
11 drives for production. JCCP Plaintiffs' Counsel also incurred time negotiating a forensic review  
12 protocol with Yahoo.

13 37. Based upon my review of the timesheet and expense reports pertaining to written  
14 discovery, the time and expenses appear reasonable, efficient, and non-duplicative.

15 Depositions

16 38. Based upon my review of the above-mentioned documents, I understand there were  
17 approximately 11 days of deposition in this case with deponents being deposed on the following  
18 dates:

- 19 a. November 10, 2017: Deposition of Yahoo 30(b)(6) Witness Sean Zadig, Director of  
20 Threat Investigations;
- 21 b. November 20, 2017: Continued Deposition of Yahoo 30(b)(6) Deposition of Sean  
22 Zadig, Director of Threat Investigations;
- 23 c. February 22, 2018: Continued Deposition of Yahoo 30(b)(6) Deposition of Sean  
24 Zadig, Director of Threat Investigations;
- 25 d. April 13, 2018: Deposition of Robert Lord, former Yahoo Chief Information Security  
26 Officer ("CISO");
- 27 e. June 8, 2018: Deposition of Robert Lord, former Yahoo CISO;

- 1 f. May 14, 2018: Deposition of Ramses Martinez, former Yahoo Interim CISO;
- 2 g. May 15, 2018: Deposition of Ramses Martinez, former Yahoo Interim CISO;
- 3 h. May 29, 2018: Deposition of Justin Somaini, former Yahoo CISO;
- 4 i. June 26, 2018: Deposition of Christopher P. Rohlf, former Yahoo Director of
- 5 Penetration Testing and Offensive Engineering Team;
- 6 j. June 28, 2018: Deposition of Alexander C. Stamos, former Yahoo CISO; and
- 7 k. August 16, 2018: Deposition of Jay Rossiter, former Yahoo Senior Vice President.

8 39. I understand that following the Court's denial of the motion for preliminary approval,  
9 MDL Plaintiffs' Counsel also deposed Jakub Slomczynski on April 2, 2019, and Dr. Edgar Whipple  
10 on April 3, 2019. Although JCCP Plaintiffs' Counsel attended both depositions, they did not submit  
11 bills for any time or expenses (such as travel to Chicago and San Francisco from Orange County)  
12 relating to these depositions.

13 40. For each of these depositions, it appears that JCCP Plaintiffs' Counsel spent  
14 substantial hours reviewing the deponent's custodial file, gathering exhibits, preparing document  
15 review memoranda and multiple drafts of lengthy deposition outlines, exchanging documents and  
16 deposition strategy with the MDL, traveling, and attending and/or conducting examination of the  
17 witnesses. Based on my review, JCCP Plaintiffs' Counsel did a very good job of minimizing any  
18 duplicative billing by ensuring that no more than two JCCP Plaintiffs' Counsel were at each  
19 deposition. JCCP Plaintiffs' Counsel also largely ensured that duplicative topics or exhibits were not  
20 repeated at subsequent depositions, unless absolutely necessary.

21 41. JCCP Plaintiffs' Counsel also made efforts before each deposition to coordinate with  
22 the MDL Plaintiffs' Counsel concerning which deposition topics would be handled by JCCP  
23 Plaintiffs' Counsel to reduce duplicative questioning and work. Costs for travel and lodging appear  
24 to have been minimal, with JCCP Plaintiffs' Counsel typically traveling economy fare and returning  
25 home in the same evening the depositions were conducted. JCCP Plaintiffs' Counsel also appear to  
26 have saved resources and costs by hosting the document review platform in-house rather than using  
27 an outside vendor.

1 42. Based upon my review of the timesheet and expense reports pertaining to the  
2 depositions, the time and expenses appear to be reasonable and proper, with minimal duplicative  
3 work product.

4 Mediation, Class Certification, and Settlement

5 43. Based upon my review of the above-mentioned documents, I understand the parties  
6 mediated the case with the Honorable Daniel Weinstein (Ret.) of JAMS, and after JCCP Plaintiffs'  
7 Counsel moved for class certification, the parties reached a settlement in principal at the second  
8 mediation session before Judge Weinstein.

9 44. On July 31, 2018, JCCP Plaintiffs' Counsel, MDL Plaintiffs' Counsel, and Yahoo  
10 each submitted a separate mediation brief. It is my understanding that efforts were made by  
11 leadership of each coordinated proceeding to minimize overlap and duplication on the briefs. On  
12 August 10, 2018, the parties attended the pre-meeting mediation with Jed Melnick, the Lead Case  
13 Manager for Judge Weinstein, in New York. On August 14, 2018, the parties attended mediation  
14 before Judge Weinstein in San Francisco.

15 45. On August 27, 2018, JCCP Plaintiffs' Counsel filed their motion for class certification,  
16 which was set to be heard on September 28, 2018.

17 46. On September 7, 2018, the parties attended a second mediation session in San  
18 Francisco before Judge Weinstein where they reached an agreement in principle. The parties  
19 subsequently agreed to a memorandum of understanding regarding the settlement. On September 14,  
20 2018, a notice of settlement was filed with the JCCP Court.

21 47. It is my understanding that by agreement, the MDL Plaintiffs' Counsel drafted the  
22 initial settlement documents and the JCCP Plaintiffs' Counsel revised the Settlement Agreement,  
23 notices, claim forms, and motion for preliminary approval. On October 22, 2018, the motion for  
24 preliminary approval of class action settlement was filed. On November 9, 2018, the parties filed a  
25 supplemental response regarding additional information requested by the Court. On November 29,  
26 2018, the Court held a hearing on the motion for preliminary approval, and ultimately denied the  
27 motion on January 28, 2019.

1 48. Following additional discovery, which the records show JCCP Plaintiffs' Counsel did  
2 not bill for, the MDL Plaintiffs filed a Second Amended Complaint, and filed a Motion to Notice  
3 Class on April 9, 2019. Following a supplemental response at the request of the Court, on June 27,  
4 2019, the parties appeared for the Motion to Notice Class hearing wherein I reviewed a hearing  
5 transcript showing that Class Counsel Daniel S. Robinson, Co-Lead Counsel for the JCCP,  
6 represented that JCCP Plaintiffs' Counsel would not bill for any of the work that occurred, or  
7 expenses incurred following the Court's denial of the first motion for preliminary approval. On July  
8 20, 2019, the Court granted the motion for preliminary approval.

9 49. JCCP Plaintiffs' Counsel's time and expenses related to class certification and  
10 mediation/settlement appear to be reasonable, proper and non-duplicative. Additionally, consistent  
11 with Mr. Robinson's representation, it appears that no time or expenses incurred by JCCP Plaintiffs'  
12 Counsel after November 6, 2018, are being submitted to the Court for compensation.

13 The Timesheets and Expense Reports All Appear Reasonable.

14 50. Given my extensive familiarity with the case discussed above and my prior  
15 experiences presiding over class actions and reviewing fee awards, I am more than able to conduct  
16 an audit of the fees and expenses claimed by the JCCP Plaintiffs' Counsel and determine whether  
17 they are reasonable, proper and efficient.

18 51. I focused my review and analysis of the timesheets and expense reports on the  
19 following specific billing issues:

- 20 a. Rates charged for attorney and non-attorney personnel of different denominations  
21 (e.g., Firm Lead Partner, Partner, Associate, Staff/Project Attorney, Contract  
22 Attorney, Paralegal/Law Clerk); and
- 23 b. Whether the time and expenses spent on a task were fair, reasonable, and proper,  
24 including ensuring there was not unjustified duplicative billing (e.g., such as  
25 attendance by multiple unnecessary counsel at a deposition or hearing).

26 52. Although I did not review every line item, I did randomly review hundreds of entries  
27 employing a project-by-project sampling methodology wherein I would review and evaluate specific

1 assignments, filings or documents, and then I would cross-reference the work billed by attorneys and  
 2 costs incurred for that specific project to make sure they were reasonable, properly documented and  
 3 non-duplicative. I feel confident that the methodology I employed when reviewing timesheets and  
 4 expense reports is adequate to determine that JCCP Plaintiffs' Counsel's billing was reasonable,  
 5 adequate and efficient.

6 53. I am also informed that Daniel S. Robinson conducted a line by line review of each  
 7 timesheet and expense report being submitted to the Court to ensure that the following guidelines  
 8 suggested by me and discussed with Class Counsel have been fully implemented:

- 9 a. Confirmed billing rates are consistent with standard Orange County practice;
- 10 b. Reduced document review billing time to \$240.00 per hour;
- 11 c. Time spent "reading and reviewing" documents is non-compensable;
- 12 d. Removed *de minimis* billers (under 5 hours); and
- 13 e. Remove duplicative and/or excessive billing.

14 54. I am familiar with billing rates for attorneys appears in the Orange County Superior  
 15 Court through my years of experience on the bench, and the rates submitted by the JCCP Plaintiffs'  
 16 Counsel appear reasonable with standard Orange County practice. To be clear, I take no position  
 17 with respect to the billing practices of the MDL Plaintiffs' Counsel, nor I have reviewed the MDL  
 18 attorneys' timesheets. Specifically, the following billing rates all appear fair and reasonable given  
 19 the attorneys' level of expertise, experience, and the complexity of the matters:

55. After the above measures were implemented and the timesheets were reviewed, the lodestar for the JCCP Plaintiffs' Counsel was reduced by approximately 23%, or from \$3,768,273.00 to \$2,906,661.00, and their hours were reduced approximately 6%, or from 7647.5 to 7180.4.

56. Given my experience on this case and keeping in mind that many of the documents I reviewed during my audit are ones that I specifically recalled seeing when I was the coordination trial judge of the JCCP, I am able to fully understand the time, effort, and expense that goes into each of the items I reviewed. The time appears reasonable, as do the total expenses of \$156,379.13.


57. Based upon my audit, JCCP Plaintiffs' Counsel appear to have complied with their internal billing protocol, as well as the guidelines recommended by me and Class Counsel. Based on my review, the timesheets and expenses appear to be reasonable and proper for time and costs efficiently incurred in this matter given the complexities of the case.

58. Again, I take no position with respect to the merits of the underlying case, the claims or defenses asserted by either party, whether the settlement itself is fair or reasonable, or any other matters beyond the scope of my review. I also take no position with respect to the adequacy of MDL Plaintiffs' Counsel billing given that I have not reviewed their timesheets or costs.

59. This declaration is submitted for the limited purpose of providing assistance to the

1 Court when reviewing the timesheets and expense reports of JCCP Plaintiffs' Counsel.
